#### What Malaysia Is Reading:

#### India, Pakistan, and the New Trade Tensions

In July 2025, Malaysian news outlets examined India, Pakistan, and the global trade war through the lens of domestic anxiety and strategic caution. Coverage of India focused sharply on Assam's mass evictions of Muslims, interpreted as communal politics ahead of elections. This aligns with Malaysia's sensitivity to religious and ethnic tensions, shaped by its own multi-ethnic identity. Pakistan-related reporting centred on immigration enforcement and the vulnerabilities of undocumented populations—both within Malaysia and in Karachi—projecting a growing Southeast Asian trend of securitising migration. Meanwhile, Pakistan's internal shift towards solar energy also drew notice, revealing economic strain and grid failures.

Trade war developments dominated the economic news cycle. Malaysia's media tracked Trump's tariff rhetoric and spotlighted ASEAN's fragility amid US-EU and US-India deals. Commentary reflected growing concern over the region's exposure to bilateralism as global institutions like the WTO lose clout. Analysts warned that the US's tariff-first approach could unravel regional supply chains, especially in textiles and electronics. In this sense, Malaysia's reportage—though national in focus—echoed broader concerns about power asymmetries, selective diplomacy, and regional instability. Whether through coverage of trade, migration, or majoritarian politics, Malaysian media portrayed a world where Southeast Asia must navigate external shocks while grappling with its own internal contradictions.

#### What Singapore is Reading:

#### India's Rise, Pakistan's Balancing Act, and Trade War Jitters

In July 2025, Singapore's leading outlets—The Straits Times and Channel News Asia—paint a layered picture of India, Pakistan, and global trade currents. India emerges as a diplomatic chameleon: rekindling ties with China through visa liberalisation, deepening trade with the UK and EU, and asserting border stances with Pakistan. ASEAN commentary advises India to forge an identity beyond China's shadow, aligning with Singapore's strategy of geopolitical hedging. Pakistan, meanwhile, appears as a state straddling diplomacy and domestic volatility—taking up the UN Security Council presidency, engaging the US in trade talks, yet cracking down on PTI supporters at home.

The bigger picture in Singapore's reporting reflects ASEAN's quiet but strategic anxiety over intensifying global fragmentation. India is increasingly seen as a counterweight—not just to China, but to the bipolarity of US-China rivalry. Singaporean media subtly endorse this diversification, seeing in India a partner for multilateral connectivity. On Pakistan, coverage reflects caution: noting efforts to normalise diplomatically, but also instability that may undermine credibility. Trade war fears, fuelled by Trump's tariff rhetoric and US-China negotiations, dominate economic commentary. Singapore's framing is clear—tariff brinkmanship threatens supply chains and trade norms. In all, Singapore's coverage reveals a region navigating great power competition through cautious optimism and rules-based realism.

#### What Brunei Is Reading:

#### India's Assertive Diplomacy, Pakistan's Global Moves, and Trade War Undercurrents

In July 2025, Bruneian media painted a nuanced picture of South Asia. India was showcased as a self-assured, tech-forward power—pushing back against Donald Trump's ceasefire claims on Kashmir while deepening diplomatic ties with the Maldives and ASEAN. Its leadership in digital payments and optimism in trade received positive coverage. Pakistan, meanwhile, earned attention for its seafood export surge, its presidency at the UN Security Council, and a major online scam involving Chinese nationals. The Myanmar conflict spilling into India brought regional instability into focus. Trade tensions loomed large, with China's resilience highlighted and ASEAN's tourism diplomacy tilting toward India.

Together, these stories reflect how Bruneian media sees South Asia's evolving role in a fragmented world order. India's dual posture—rejecting Western mediation while expanding its regional soft power—signals its growing comfort in acting as a key Indo-Pacific player. Its emphasis on digital solutions aligns with a broader South-South tech narrative. Pakistan's seafood success and UN leadership suggest attempts to craft a constructive international image, despite domestic governance flaws. The coverage of trade war ripples—especially China's pivot and ASEAN's India-friendly tourism push—suggests Southeast Asia is recalibrating ties. Brunei's reporting positions India and Pakistan not as rivals in isolation, but as adaptive players in a shifting global system where diplomacy, tech, and trade realignments matter more than ever.

#### What Cambodia Is Reading:

#### India's Rise, Pakistan's Shadows, and the Trae War Tremors

In July 2025, Cambodian media portrayed India as an assertive yet collaborative power. India's rejection of NATO's critique on Russia trade was framed as a strong defence of sovereign economic choices, reflecting broader Global South pushback against Western pressure. Coverage highlighted India's expanding footprint in Cambodia—through pharma exports, agri-finance pacts, and education scholarships—while also recognising New Delhi's growing competition in textiles. India's simultaneous outreach to both China and the West (QUAD, UK trade deal) presented it as a strategic balancer. In contrast, Pakistan surfaced minimally, with focus on its controversial move to issue passports—but not citizenship—to Rohingya refugees. On trade wars, Cambodia's media tone was cautious, tracking tariff tensions (US-EU, China, Asia) while welcoming multilateral efforts like QUAD's mineral pact.

The broader takeaway is that Cambodian news coverage reflects Southeast Asia's growing awareness of India's evolving regional role. India is seen as a rising partner blending soft power (scholarships, MoUs) with strategic assertiveness. Cambodia's economic and diplomatic reporting subtly signals an ASEAN-wide preference for multipolar engagement—resisting bloc alignment in favour of flexibility. Meanwhile, the trade war coverage captures regional unease with economic fragmentation, underscoring ASEAN's vulnerability to global supply shocks. Pakistan's brief presence in coverage signals regional human rights concerns rather than political weight. India, however, is front and centre—economically entangled, diplomatically agile, and geopolitically rising.
